WHEREAS, the Board of Directors of the Centennial Crossing Metropolitan District No. 2 appropriated funds for the fiscal year 2023 as follows:

WHEREAS, the necessity has arisen to account for other expenditures and transfers by the District that could not have been reasonably anticipated at the time of adoption of the budget, requiring changes to the appropriation for the fiscal year 2023.

NOW THEREFORE, BE IT RESOLVED that the Board of Directors of the Centennial Crossing Metropolitan District No. 2 shall and hereby does amend the budget for the fiscal year 2023 as follows:

**General Fund:**


<b>Revenue</b>	<b>\$ 147,175</b>

<b>Other funding sources</b>	<b>(\$291,884)</b>
<b>Ending fund balance</b>	<b>\$ 431</b>

NOW THEREFORE BE IT RESOLVED, that such sums are hereby appropriated by the District to the General Fund for the purposes stated, and that any ending fund balances shall be reserved for purposes of Article X, Section 20 of the Colorado Constitution.


